Tuition Information

Monthly Tuition

Ankh Academy of the Arts offers high-quality, engaging, multi genre dance instruction at an accessible rate.

-Tuition is billed monthly from September or October(depending on when your center starts classes) through June.

-Autopay is processed during the second week of each month, through our online platform, with a valid credit card on file.

-Aftersubmitting your registration paperwork, you will receive an email with a username and password, to set up your online account.

-Sibling Discount: Families will receive a 10% discount on monthly tuition for each additional child enrolled.

-Payments will happen on the 10th of each month, through Autopay, with the saved card on file, to secure your child's spot in class.

Registration Fee

-A one-time, non-refundable registration fee of \$35 is due at the time of enrollment.

Additional Information

-Tuition is based on a 9/10-month school year schedule and remains the same each month regardless of holidays

Early Withdrawal Policy

-If I choose to withdraw my child from the program, before the end of the 9 or 10-month session, I understand that I am responsible for an early withdrawal penalty, equal to one month's tuition, due at the time of withdrawal.

We are honored to have your family as part of our community. The following outlines our tuition policies to ensure clarity, consistency, and shared expectations throughout the year.

TUITION POLICIES

1. Program Duration & Commitment

Ankh Academy of the Arts operates on a 9 or 10-month tuition schedule (September through June). Tuition is calculated annually and divided into 9 or 10 equal monthly installments, regardless of the number of classes given per month.

2. Tuition Responsibility

I understand that I am financially responsible for the full 9/10-month tuition commitment. Monthly tuition is due on the second week of each month, and a \$15 late fee will be applied after a 5-day grace period.

3. Early Withdrawal Policy

If I choose to withdraw my child from the program before the end of the 9 or 10-month session, I understand that I am responsible for an early withdrawal penalty equal to one month's tuition, due at the time of withdrawal. (contingent upon the circumstances)

4. Missed & Makeup Classes

Tuition is based on enrollment, not attendance. Make-up classes may be offered when available. If classes are canceled due to unforeseen events (such as weather, parent teacher conferences, emergencies, or certain school closures), Ankh Academy will work with your location to arrange appropriate make-up opportunities when possible. Tuition will not be reimbursed or prorated for missed classes due to student illness, absences, or vacations.

5. Showcase & Costume Fees

Showcase participation is encouraged but not required. Families choosing to participate will be responsible for costume purchases and performance fees (if applicable), which will be communicated well in advance.
